Awards:

First Place	\$500.00 and Trophy
Second Place	\$200.00 and Trophy
Third Place	Trophy

Criteria:

1. Artistic skills
2. Costumes
3. Synchronizing with Rhythm
4. Facial Expression
5. Stage Presentation

Guidelines/Regulations:

1. All contestants are required to be on time, check in and be prepared for the competition. If you arrived late, you will be automatically removed from the competition.
2. Any contestant who violates the Requirements/Criteria/Regulations established by Hmong Community of Metro-Detroit, Inc. (HCMD) will be terminated from the competition.
3. **HCMD reserves the rights** to use any audiotape, videotape and photographs that were recorded or took during the event for any press releases, fundraising purposes and/or calendar printing.
4. Contestants are **not allowed to register** with different dancing groups.
5. **HCMD is not responsible for any lost or stolen item(s) and/or is not liable for any accident or injury occurred before, during, or after the event in any place and/or at any time.**
6. **Two dances** are required to compete in the competition. Dancing selection music/dance is limited to **five (5) minutes** per dance.
7. **HCMD reserves the right to cancel the Dancing Competition if there are less than five (5) groups registered by September 23, 2011. You will be notified by September 24, 2011 if there are less than five (5) groups registered.**
8. If your group shall win the **2012 Dancing Competition First Place**, you are **required to perform at any public events and functions as set by HCMD without charging any fee. You are also required to perform a final dance routine** before HCMD crowns its 2012 Miss Hmong Michigan winner.
9. Hmong Community of Metro-Detroit, Inc. **reserved the rights to disqualify any contestant regardless of any reason.**
10. **The decisions of the judges are final.**
