2. Weekend Vendor Parking Pass will be issued to all Vendors upon entry into the event premise. LIMIT ONE PER VENDOR. Vendors who choose to "PUA LEV" DO NOT QUALIFY for parking pass.
3. For the safety of everyone in the park, vendors are **NOT** permitted to sell any type of alcohol or any illegal commodities, and any type of **air guns or projection devices**. Any violation will result disqualify for a booth and will be asked to leave the premise right away.
4. HCMD is not responsible FINANCIALLY OR LEGALLY for injuries, fires, theft, or accidents that occurs within or near the proximity of a booth. It is the responsibility of the Booth owner to maintain a safe working environment which will be harmless to the general public.

It is very important that every vendor reads and complies with the following rules and regulations.

5. Each vendor has the responsibility to clean his/her area upon departure, failing to do that will result in losing his/her security deposit.
6. Security deposits will be sent out one week after the events.
7. **NO MUSIC OR MOVIES CAN BE TURNED ON BEFORE 8AM OR AFTER 8PM.** Failure could result in security deposit refusal.
8. If you reserved a vendor number, and mailed in your deposit and you **DO NOT** show up for the event, you will loss your deposit. You **MUST** give HCMD a 48 hours notice if you are not able to attend the event in-order to secure your deposit.
9. HCMD reserves the right to remove any vendor from the event premise and report any illegal activities to the law enforcement authorities if they are not complied with the rules and regulations of the HCMD and the Clinton TWP.
